METALLIC MINERAL EXPLORATION IN WISCONSIN

Summary of 1985 Activity

HIGHLIGHTS OF 1985 ACTIVITY

Metallic mineral exploration¹ in Wisconsin plummeted to its lowest level since accurate records of annual activity became available beginning in 1978. Exploration drilling in 1985 totaled 24 drillholes, down over 55 percent from 1984. Total footage drilled, however, increased 17 percent as compared to 1984 reflecting the shift back to more traditional metallic mineral exploration. (In 1984, 19 drillholes averaging only several tens of feet deep were drilled to evaluate placer gold potential in Pierce County.) Bedrock footage showed a similar increase (15 percent) in 1985. If development drilling related to the Crandon Project is excluded, however, exploration drilling in terms of total footage drilled and footage drilled in bedrock decreased in 1985 as compared to 1984.

Metallic mineral exploration occurred in seven counties in 1985. Five companies were active out of a total of 16 companies that held exploration licenses at some time during the 1985 calendar year.

^{1. &}quot;Exploration" has a specific legal definition in Wisconsin (NR 130.03(8), Wis. Admin. Code) that is essentially synonymous with "drilling." Unless otherwise stated, this definition is followed in this report.

Exxon Minerals Company completed four drillholes on the site of its Crandon Project in Forest County. This exploration effort, since it focused on the already announced massive sulfide orebody present in section 25, T. 35 N., R. 12 E. and section 30, T. 35 N., R. 13 E., represent drilling for purposes of mineral development. Developmental drilling is exploration under Wisconsin law, but typically is not designed to locate mineral deposits, but is intended to gather additional information for actual mineral development. The Crandon Project is expected to be the subject of draft and final environmental impact statements during 1986. The master hearing on all related permit applications is scheduled for early 1987.

Leasing for purposes of metallic mineral exploration was minimal in 1985 according to a survey completed in early 1986². Only 1,110 additional acres were leased for metallic minerals in Wisconsin last year as compared to over 477,000 acres leased for purposes of oil and gas exploration. This limited new leased acreage for metallic minerals indicates the currently weak interest in metallic mineral development in Wisconsin. Leasing in 1985 was down by 60 percent as compared to 1984, which had declined by over 80 percent from the 1983 leasing level.

Nonmetallic mineral exploration activity of interest in 1985 included the May 1985 announcement by Amoco Production Company of its intent to construct a 12,000-foot deep exploration drillhole for purposes of evaluating petroleum potential along the billion-year-old (Keweenawan) Midcontinent Rift. The proposed drillhole was to be located in Bayfield County. Amoco announced a postponement of its drilling plans just two weeks later. Falling oil prices late in 1985 make the possibility of petroleum exploration in Wisconsin in 1986 most unlikely. Collection of geophysical data in 1985 for purposes of evaluating petroleum potential was highlighted by the acquisition of over 200 line-miles of seismic information in Lakes Michigan and Superior by a consortium of companies. Land-based geophysical activity for 1985 is not available but in 1984 included over 350 line-miles of seismic information. Parts of these data are available for purchase Whereas other parts remain proprietary.

Also of interest in terms of nonmetallic mineral exploration was leasing and exploration for diamonds in southeastern Wisconsin and in the Pierce County area of west-central Wisconsin. At yearend, all diamond-related activity in southeastern Wisconsin had ceased and leases were dropped. The Pierce County area remained under evaluation going into 1986.
